- 7. Entry Fees:

No HTCS starting fee. (If not checked in 30 min before first race of card, even if scratched, \$100 is payable to Lorain County Fair.)
\$100 per horse for Signature Series events.

- 8. Purse Distribution: 50% 25% 12% 8% 5%. HTCS purse structure listed in circuit rules.
- 9. EIN or SSN for owners are required before any purse money will be paid.
- 5. Live of 5514 for owners are required before any parse money will be paid.
