No HTCS starting fee. (If not checked in 30 min before first race of card, even if scratched, \$100 is payable to Lorain County Fair.)  
\$100 per horse for Signature Series events.
- Purse Distribution: 50% - 25% - 12% - 8% - 5%. HTCS purse structure listed in circuit rules.
- EIN or SSN for owners are required before any purse money will be paid.
- Lorain County Fair is not responsible for accidents on or off the track.
- Lorain County Fair reserves the right to postpone, declare off, change the program, or refuse any entry.
- All HTCS Members should belong to Ohio Harness Horsemen's Association.
- Buckeye Consortium passes honored at the gate on racing days only.
