## SOLARFEST 2024 CAMPING

### Regulations & Application

APPLICATIONS DUE: MARCH 25, 2024

- Applications for camping will be accepted by mail, online, or in person at the Secretary's Office. Camping fees are \$175 for campers, \$100 for pop-up campers, and \$100 for tent camping. **Camping fees do not include an admission fee per person.** Application and fees are due by March 25, 2024.
- Campers can enter the fairgrounds property starting Saturday, April 6, 2024, at 10:00 am. All campers must be removed by Tuesday, April 9, 2024, at 5:00 pm.
- No campfires.
- Camping sites do not include water and electric is available on a limited basis. Restrooms and showers will be available.
- FIRE LANES/DRIVES are to be kept open at all times! Cooperate for your safety and protection.
- PETS must be restrained/leashed at all times and you must clean up after your pet.
- Quiet hours are from 10:00 pm to 6:00 am. All unnecessary lights must be extinguished, and sound producing items must be reduced to a decibel level that is satisfactory to your neighbors.
- An adult must accompany each campsite.
- All pressurized cylinders, whether in use or in storage, shall be chained or metal strapped and capped in a stable vertical position, so they will not fall over, and placed out of the way to protect from any physical damage.
- Intoxication will not be permitted.
- No gray water or sewage is to be discharged onto the ground.
- The Fair Board, in cooperation with the Wellington Fire Department, asks that you consider having a working smoke alarm and an updated fire extinguisher per each camper.
- Do not affix anything to Fair Board property.
- Each camper will be assigned a number tag that needs to be displayed in the window nearest to the drive.
- The Fair Board will rule on any questions not covered in these regulations.
- The Fair Board has the right to assign campers to any spot or location as needed.
- Camping spaces cannot be resold or used by anyone other than those listed on the application.
- THE LORAIN COUNTY AGRICULTURAL SOCIETY RESERVES THE RIGHT TO CANCEL A CAMPING CONTRACT AT ANY TIME AND TO REFUSE OR REJECT ANY APPLICATIONS FOR CAMPING AND WILL NOT BE HELD RESPONSIBLE FOR ACCIDENTS OF ANY SORT.
- Unruliness or Poor Attitude: Campers who become unruly or belligerent, or who do not adhere to the rules above, will be removed.
