

**PARTICIPANT AGREEMENT, RELEASE AND
ACKNOWLEDGEMENT OF RISK TWISTED PLASTIC
PRODUCTIONS**

In Consideration of the services of Twisted Plastic Productions their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in capacity on their behalf I hereby agree to release and discharge Twisted Plastic on behalf of myself, my children my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that Demolition Derby's entail known and unanticipated risks which could result in physical or emotional injury, paralysis, death or damage to myself, to property, onto third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. The risks include, among other things: Collision with other cars, the walls or other fixed objects; falling down; my own equipment failure or the failure of other's equipment; my own or other's negligence; objects or conditions on the grounds/surface that may cause me to fall; broken bones; sprains; head, neck and back injuries, abrasions, and bruises.
Furthermore, Smash It employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They may give inadequate warnings or instructions, and the equipment being used might malfunction.
2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Twisted Plastic from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of Twisted Plastic equipment or facilities, including such Claims which allege negligent acts or omissions of Twisted Plastic
4. Should Twisted Plastic or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage to myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume -and bear the costs of- all risks that may be created, directly or indirectly, by any such condition.

By signing this document, I agree that if anyone hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Smash It on the basis of any claim from which I have released them herein.

I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
